The proposed By-Law would prohibit the establishment of Marijuana Retailers in Ware, such retailers being defined in G.L. c94G, §1 as "... an entity licensed to purchase and deliver marijuana and marijuana products from marijuana establishments and to deliver, sell or otherwise transfer marijuana and marijuana products to marijuana establishments and to consumers." If passed, the proposed By-Law would not prohibit any other type of marijuana establishments such as marijuana cultivators, marijuana testing facilities, marijuana product manufacturers or medical marijuana establishments. Further, the proposed By-Law would not be effective until and unless it is also passed by Town Meeting vote.</p> <p>By-Law: The operation of Marijuana Retailers, as defined in M.G.
